

# **Terms & Conditions of Use**

- Definitions (i) "BWM" or "BWM Wine Merchant" or "we" or "us" or "our" refers to BWM Wine Merchants Pty Ltd as Trustee for BWM Wine Merchants Trust (ABN 72 338 923 086), including its executors, administrators, successors, and assigns in Australia. (ii) "Customer" or "you" or "your" refers to the person or entity purchasing goods from BWM, regardless of whether an account application has been completed. This includes the customer's employees, authorized persons, and users who access BWM's online ordering portal under the domain bacchuswinemerchant.com.au.
  - (iii) "Online Ordering Portal" or "bacchuswinemerchant.com.au" refers to the ordering platform, portal, app, software, website, or any other digital method BWM provides for customers to search for products and make purchases from BWM.
  - (iv) The singular includes the plural, and vice versa, and any gender includes all genders.
  - (v) References to a person include corporations, partnerships, joint ventures, associations, or other legal entities.
  - (vi) References to statutes, statutory provisions, or regulations include all amendments, consolidations, or replacements thereof.
- Purpose of bacchuswinemerchant.com.au The bacchuswinemerchant.com.au online portal is provided by BWM to approved customers to view product information, place orders, and access account details. The features and functionalities available are subject to BWM's sole discretion and may be modified or changed at any time without notice.
- 3. **Changes to bacchuswinemerchant.com.au** BWM reserves the right to modify, adjust, or remove any features or functionalities of bacchuswinemerchant.com.au at its absolute discretion.
- 4. New Features From time to time, BWM may introduce new features to bacchuswinemerchant.com.au to enhance user experience. However, BWM advises against storing sensitive information on the portal and accepts no liability for loss of any data saved in bacchuswinemerchant.com.au.

  - (ii) Stock availability updates every 24 hours; therefore, all orders are subject to actual stock availability. For urgent orders, check with your sales representative.
  - (iii) Prices displayed are for reference only. The invoice price is based on the pricing structure set by BWM for each customer. Contact your sales representative if you have

- concerns about pricing.
- (iv) BWM reserves the right to change product descriptions, pricing, and availability without notice.
- 7. **Customer Responsibility** (i) You are responsible for maintaining the confidentiality and security of your account login information. Unauthorized use of your account, including access granted to others, is your responsibility, and BWM will not be held liable.

  (ii) Notify BWM immediately if there is a security breach of your account. You will indemnify BWM against any claims arising from unauthorized use of your account.
  - (iii) Changes to shipping addresses must be communicated to BWM by email, with attached licensing details for verification. Orders can only be shipped to licensed addresses registered with BWM.

  - (ii) Duplication of any content, in part or whole, without permission is prohibited.

- 10. **Assignment** BWM may assign its rights under these terms without your consent. However, you may not assign your rights under these terms without BWM's written consent.

- 12. **Pricing and Charges** (i) All orders and purchases placed via bacchuswinemerchant.com.au will be recorded and charged to you. The price payable for the products ordered will be determined based on the pricing Bacchus Wine Merchant (BWM) has set on your account with BWM or based on the selling price set by BWM. Wine Equalisation Tax (WET) and Goods and Services Tax (GST) will be applied to the purchase of our products at the applicable statutory rate (for example, 10% for GST and 29% for WET) in accordance with the law.
  - (ii) You are responsible for any taxes, duties, or other liabilities imposed by any governmental agency, including without limitation, any customs duty, goods and services taxes, or any value-added tax imposed on any products or services acquired or ordered by you from bacchuswinemerchant.com.au.

## 13. Limitation of Liability

- (i) BWM does not warrant the uninterrupted or error-free functioning of bacchuswinemerchant.com.au and will not be liable for any direct, indirect, incidental, or consequential damages arising from the use or inability to use the portal.
- (ii) BWM disclaims any warranties, express or implied, including but not limited to implied warranties of merchantability and fitness for a particular purpose.
- (iii) Under no circumstances will BWM be liable for any damages resulting from the loss of data, profits, or use, even if advised of the possibility of such damages.

#### 16. Severability

If any provision of these Terms & Conditions of Use is found to be invalid or unenforceable by a court of competent jurisdiction, such provision will be severed from the remaining terms, which will continue in full force and effect.

# 17. Entire Agreement
